Program Participation Agreement for APPLICANT and BUSINESS/ORGANIZATION

ATTENDANCE COMMITMENT: (One day a month for sessions) – Friday – Retreat/7 sessions are required 1½ Day Retreat: September 23: Day One – ½ day on Community Issues/Service Learning Course; September 24: Day Two – Team Building Learning Course. Leadership Tomorrow Program day sessions start in October 2010 and finish in May 2011 with graduation. Program days begin at 8:00AM and end at 4:30PM with occasional time outside of class, especially for Criminal Justice Day. Class participants will be required to complete the Service Learning course, which includes a minimum of 75 service credit hours for one DACC college credit; written documentation (journal) of community volunteerism; and a class project is required. Attendance is mandatory at Retreat and six sessions for graduation.

Participants in the Leadership Tomorrow program must have the support and commitment of their business or organization. Both applicant and employer must sign the application as an indication of this support and commitment. The nominees must also have the financial commitment required to participate effectively in Leadership Tomorrow.

Class tuition is due on notification of acceptance into Leadership Tomorrow, 2010-11, Class 23.
